
# LOCAL COMMUNITIES WITH HEART

The St Vincent de Paul Society is dedicated to shaping a more just and compassionate society. With over 1,500 volunteers, over 500 members and over 240 professional staff, our organisation is uniquely placed to respond to the needs of local communities.

In the Canberra/Goulburn region we assist through:

- The emergency support helpline
- Home visitations and provision of food & clothing
- Blue Door drop-in centre offering free meals
- Advocacy on social justice issues and support for migrants and refugees
- Crisis accommodation and support for families and individuals experiencing homelessness
- Camps and excursions for disadvantaged youth and respite and recreation for young carers
- Clemente Education Program with ACU to provide people with the practical skills and knowledge to break the cycle of disadvantage
- Night Patrol vans our volunteers visit the streets of Canberra and Queanbeyan every night of the year, providing engagement, material aid and light refreshments to people in need.

There are a variety of ways to include a gift in your Will to the St Vincent de Paul Society Canberra/Goulburn.

- Residue: The remainder of your estate once all other legacies and expenses have been deducted.
- Percentage of your estate.
- Specific sum: You may nominate a specific sum of money in your Will.
- Property: A gift of real estate.
- Stocks & shares: A percentage of stocks and shares in your portfolio.
- Superannuation and/or Life Insurance policies: Nominate the St Vincent de Paul Society Canberra/Goulburn as a beneficiary.

#### WILL WORDING

Should you generously decide to include a gift to the St Vincent de Paul Society in your Will, please use the following wording to ensure your wishes are fulfilled:

Free from all duties and testamentary expenses to St Vincent de Paul Society for its general purposes and I direct that the receipt of the organisation shall be full and sufficient discharge to my executors for this gift in my Will".

#### HOW YOUR GIFT WILL BE USED

We welcome gifts made unconditionally so we can direct funds to the area of greatest need. If you choose to leave a gift to a specific area, we recommend you express this as a wish, not a condition. This gives us the flexibility to transfer your gift to a similar area of work if it is no longer possible to fund the specific area you requested.

Bequests are treated with great respect by the Society, and a special committee who determines the best use of this important legacy.
